THIS CAUSED REVENUE TO EXCEED THE AUDIT THRESHOLD SET BY THE MINNESOTA ATTORNEY GENERAL'S OFFICE. AN AUDIT WAS COMPLETED, WHICH ALSO CHANGED SOME OF THE RESPONSES ON THE 990 (PART IV 11F & 12A, PART XII) AND ADDED SCHEDULE D. THE AUDITED FINANCIAL STATEMENTS WERE REQUIRED TO BE ACCRUAL BASIS, WHICH CAUSED PLEDGES RECEIVABLE TO BE RECORDED. A FEW OTHER CHANGES WERE MADE TO THE AMENDED 990 AS IT WAS BEING RE-DONE (ITEM K ON P. 1 WAS CHANGED TO CORPORATION, ITEMS IN PART X WERE RECLASSIFIED, AN ITEM IN PART VIII WAS RECLASSIFIED, AND A FEW OTHER MINOR CHANGES).
